



Inward Bills for Collection

Save time and release your goods as soon as the shipping documents arrive. ¹



Bills for collection (B/C) is a type of trade payment in which a partner agrees that once the exporter has shipped the goods, bills and shipping documents will be submitted via the remitting bank (exporter bank) and couriered to the collecting bank (importer bank). In exchange for the shipping documents, the importer must pay or certify in accordance with the terms of the bills.

If the charge is successful, the collected funds will be remitted to the exporter via the remitting bank without any obligations.

Service Features

SCB offers a service to accept inward bills for collection, as well as shipping documents couriered from the remitting bank, which may be released once you comply with the terms and conditions specified in the documents.

In order to send documents to SCB via the remitting bank, the exporter should be informed of SCB's address as follows:

Once SCB has received the documents, you are required to comply with the terms and conditions in exchange for the shipping documents. Typically, there are two types of conditions:

- **Documents against Payment (D/P):** requires the importer to pay the amount of the draft at sight.
- **Documents against Acceptance (D/A):** requires the importer to accept the amount of the draft and make payment by the maturity date.

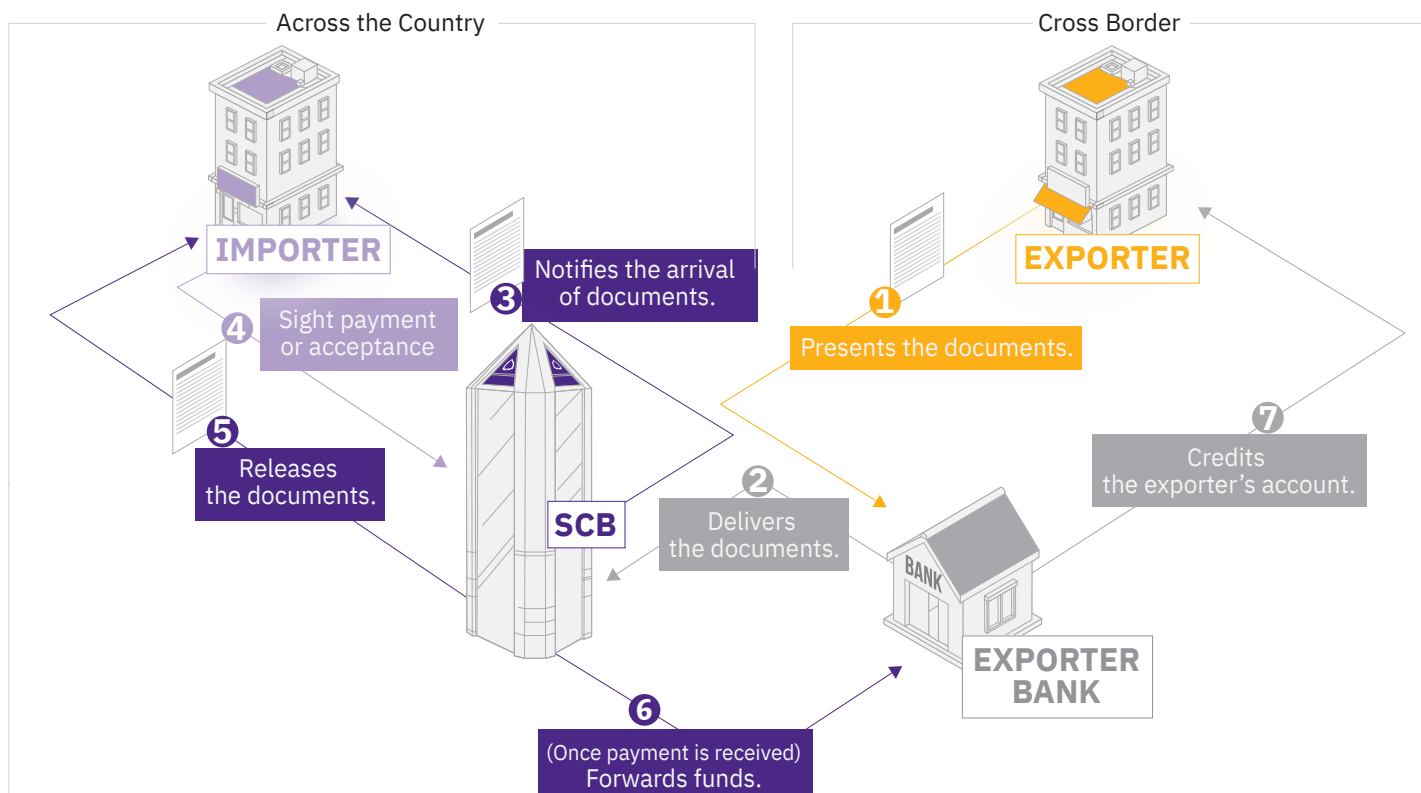
SCB accepts bills from your exporter's remitting bank through our global partner bank networks.
