In case the customer applies for the SCB Transaction Banking (Business Anywhere) Package, the customer will receive all the services in such package as prescribed by the Bank whereby the customer cannot choose to apply for individual services. Therefore, the fee rate that customer shall have to pay will be the fee rate as prescribed in the package in accordance with the promotional campaign. However, in case the customer wishes to apply for the service individually, the Bank will offer the service individually and the fee rate of such service will be in accordance with the Bank's fee announcement. 2.In case the customer receives funds transfer in foreign currency from overseas during the promotional campaign period and executes the selling transaction of such funds in order to exchange into Thai Baht with the Bank after 31 January 2026, the customer will not receive the benefit from preferential foreign exchange rate. 3.In case the customer executes a foreign currency transaction in accordance with this promotional campaign, the Bank will charge fee and use foreign exchange rate at the special rate for inward and outward remittance transactions only.
